



RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT

***WARNING: BY SIGNING THIS DOCUMENT YOU WILL WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE – PLEASE READ CAREFULLY**

ASSUMPTION OF RISKS:

I am aware that attending the property where dog training, seminars, workshops or any dog training related classes, is not without risk to myself, members of my family, or guests who may attend, or my dog, because some of the dogs to which I (we) will be exposed may be difficult to control and may be the cause of injury even when handled with the greatest of care, and that by participating in those activities (hereinafter collectively referred to as "the Activity") involves inherent risks, dangers and hazards including, but not limited to the following: all manner of injury including death, catastrophic injury or damage to property resulting from, among other things, dog bites, scratches and/or physical exertion. **I freely accept and fully assume all such risks, dangers and hazards and the possibility of personal injury, death, property damage or loss, including injury to any dogs, resulting from the participation in the Activity.**

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT:

In consideration of approval to participate in the Activity, I hereby agree as follows:

Initial TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against the owner of the premises wherein the Activity is held, as well as **RANDY MATTSON, OWNER/OPERATOR OF ADVANCED K9 TRAINING AND SERVICES**, and its Employees, and Representatives, Coaches, Leaders, Contractors, Agents and Representatives, Advertisers, Volunteers, Others participating in any capacity, (all of whom are collectively referred to as "the Releasees") from any and all liability for any loss, damage, injury or expense that I may suffer as a result of my use of or my presence at event facilities, or my participation in any part of, or presence at, any or all of the games, events and related activities of the Releasees due to any cause whatsoever;

Initial TO RELEASE THE RELEASEES from any and all liability for any loss, damage, injury or expense that I may suffer; my next of kin may suffer; or my dog may suffer as a result of my participation in the Activity, **due to any cause whatsoever, INCLUDING NEGLIGENCE, BREACH OF CONTRACT OR BREACH OF ANY STATUTORY OR OTHER INCLUDING ANY DUTY OF CARE OWED UNDER THE RELEVANT OCCUPIERS LIABILITY ACT ON THE PART OF THE RELEASEES (i.e. damage or harm caused by any dog participating in the Activity).** It is my responsibility to ensure that I have adequate medical, personal health, dental and accident insurance coverage, as well as protection for my dog and my personal possessions;

Initial TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to property of, or personal injuries to, myself or any third party, resulting from my participation in the Activity— Including any injury to myself, dogs, or property caused by myself, my dog or any other Participant or their dog;

Initial This agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives in the event of my death or incapacity;

_____ In entering into this Agreement, I am not relying upon any oral or written representations or statements made
Initial by the Releasees other than what is set forth in this Agreement;

_____ I have satisfied myself, and believe, that I am physically, emotionally and mentally able to participate in this program, and that my
Initial equipment is appropriate for use in this program;

_____ I understand that dog training participation safety must be followed at all times the sole responsibility for personal
Initial safety remains with me;

_____ I will immediately remove myself from participation, and notify the nearest trainer, if at any time I sense or observe any unusual
Initial hazard or unsafe condition or if I experience any deterioration in my physical, emotional or mental fitness, or that of my equipment,
or exceed my comfort level, for continued participation in any event or related activities;

_____ AN AGREEMENT NOT TO SUE THE RELEASEES for any loss, injury, costs or damages of any form or type, howsoever caused
Initial or arising, and whether directly or indirectly, from my participation in any aspect of the said training and related activities;

_____ AN AGREEMENT that this document be governed by the laws, and in the courts of the Province or Territory in which the said
Initial events and related activities take place.

I HAVE READ AND UNDERSTAND THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN SUBSTANTIAL LEGAL RIGHTS WHICH I AND MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS AND ASSIGNS MAY HAVE AGAINST THE RELEASEES.
